The potential buyer met with DEC, Region 8 staff, and have decided they are no longer interested in this property.

We will continue to follow-up on previous offers and consider new ways to market this property.

Grants

Mr. Humbert reported the following:

- The Land Bank Initiative, Round 2, Application was submitted to HCR for \$2 million, the maximum allowable request.
- The EPA Brownfield Grant application is still under review. Stantec reports that based on the low number of applicants, we stand a good chance of being awarded this funding.
- The Town of Lyons and Land Bank have been in discussions with NYS Economic Development about the Town of Lyons Restore-NY Grant. This application is still active and we are optimistic we will receive some level of funding.

County Agreement

The contract with the County for leasing space and receiving IT support needs to be updated. Mr. Humbert and Ms. Flynn will negotiate an updated contract and bring it back to the Board at the April WCRLB meeting for consideration.

County Tax Foreclosure

Property owners have until April 28 to pay outstanding taxes to the County. Mr. Humbert and Ms. Flynn will be meeting with Patrick Schmitt, Wayne County Treasurer, to begin to discuss possible properties to be transferred to the Land Bank. An update will be provided at the April Meeting.
